## Frequently Asked Questions (FAQs) for First and Final Call Payment

### 1. Who is required to pay the First and Final Call Money?

The holders of **Partly Paid-up Rights Equity Shares** of Lloyds Engineering Works Limited, on which the First and Final Call Money remains unpaid, are required to make the payment.

### 2. How much amount is payable?

The First and Final Call Money payable is **₹16.00 per Partly Paid-up Rights Equity Share**, comprising:

- **₹0.50** towards Face Value
- **₹15.50** towards Securities Premium

In addition, **interest at 10% per annum**, as applicable, is payable on the unpaid amount.

### 3. What is the payment period?

The payment window is open from:

- **Start Date:** Monday, 15 June 2026
- **Last Date:** Tuesday, 14 July 2026

Payments received outside this period will not be accepted.

### 4. What are the available modes of payment?

Payment can be made **only by Cheque or Demand Draft** deposited at the designated **ICICI Bank Collection Centres**.

Online payment facilities such as **ASBA, Physical ASBA or 3-in-1 Trading Accounts are not permitted**.

## 6. Can payment be made after 14 July 2026?

No. Payments received after the last date will not be accepted.

## 7. What will happen if I do not pay the Call Money?

Failure to pay the First and Final Call Money within the stipulated period may result in **forfeiture of the Partly Paid-up Rights Equity Shares**, including the amount already paid on such shares, in accordance with the applicable provisions of the Companies Act, 2013 and SEBI ICDR Regulations.

## 8. Can I claim TDS deduction on the interest amount?

Yes. Shareholders wishing to avail TDS deduction on the interest amount should submit the duly filled and signed **Annexure-2**, along with a copy of the deposited Cheque/Demand Draft, to the Company and the Registrar before processing of the interest payment.
